*Abstract:* This information collection will allow an organization to seek initial or renewed accreditation of a nonattorney representative to appear in immigration proceedings before EOIR and/or the Department of Homeland Security (DHS). This information collection is necessary to determine whether a representative meets the eligibility requirements for accreditation pursuant to 8 U.S.C. 1103, 1229a, 1362 and 8 CFR 1292.11-19. Requests can be made using a fillable .pdf application or electronic submission. EOIR has made non-substantive changes to the current Form EOIR-31A. These changes include revisions to the form's Privacy Act notice; addition of the expiration date for OMB approval on the form; updates to the address to which applications can be submitted; and addition of an alternative method by which applications can be submitted.

<sup>1</sup>5. *Obligation to Respond:* The information requested on this form is authorized by 8 U.S.C. 1103, 1229a,

1362 and 8 CFR 1292.11–19 in order to determine whether the organization has established a practitioner's eligibility to represent clients in immigration proceedings before EOIR's immigration courts, EOIR's Board of Immigration Appeals (BIA), and/or DHS. This is a voluntary collection of information and will be used by EOIR to assess an organization's eligibility for recognition and a representative's eligibility for accreditation; however, failure to provide the requested information may preclude consideration of an accreditation request.

6. Total Estimated Number of Respondents: It is estimated that 747 respondents will complete the form annually for initial accreditation and 314 respondents will complete the form annually for renewal of accreditation.

7. *Estimated Time per Respondent:* It is estimated that it will take an average
