EOIR Announces 11 Immigration Judges and 25 Temporary Immigration Judges

FALLS CHURCH, Va. – The Executive Office for Immigration Review (EOIR) announced today the investiture of 11 immigration judges and 25 temporary immigration judges who joined immigration courts in California, Connecticut, Florida, Illinois, Indiana, Louisiana, Maryland, Massachusetts, Missouri, New York, North Carolina, Tennessee, Texas, Utah, Virginia, and Washington.

Director Daren K. Margolin delivered remarks and Acting Chief Immigration Judge Teresa L. Riley administered the oath of office during the investiture, which was held today at EOIR Headquarters in Falls Church, Virginia.

EOIR is restoring its integrity as a preeminent administrative adjudicatory agency. These new immigration judges are joining an immigration judge corps that is committed to upholding the rule of law.
