

ASYLUM PROGRAM

April 2001

Changes to Asylum Program:

- The mission of the Asylum Program has broadened in scope to encompass more than the asylum reform processing caseload of new receipts and the pre-reform backlog. On February 2, 1998, the Attorney General approved the INS proposal to integrate the adjudication of certain suspension of deportation or cancellation of removal requests under the Nicaraguan Adjustment and Central American Relief Act (NACARA) into the affirmative asylum process. Under this new program, asylum officers have been delegated the authority to grant suspension of deportation or cancellation of removal to certain beneficiaries of NACARA who are eligible for the benefit. In addition, the AOC conducts credible fear interviews for all persons placed in expedited removal who request asylum or express a fear of returning to their home countries as well as credible fear interviews for non-expedited detained asylum seekers. The final component of the AOC caseload is undertaking details to overseas locations to interview and process applicants for refugee status. These operations compose the current workload of the Asylum Program.

Changes to Asylum Data in FY 1997:

- As of April 1, 1997, two procedural changes occurred which impact on asylum case completions.
 - a) The AOC cannot grant a case until identity and record checks have been finalized, per the 1996 Act. Applicants can be recommended for approval but the final decision cannot be issued until FBI fingerprint clearances have been received. Under previous procedures, these cases went directly to final approval, and were therefore included as case completions.
 - b) A second change occurred with the onset of *ABC* case processing-- *ABC* cases require processing under the 1990 asylum regulations, among other procedures stipulated in the agreement, necessitating writing preliminary decisions in addition to final decisions. Processing of these cases from interview to completion is very time consuming, unlike reform cases.As a result of these two procedural changes, case completions declined, while interviewed cases moved through the processing pipeline to final decision. Late in FY 1997, final approvals reached completion on a large scale, which continued into FY 1998.
- The workload report was modified to include data on preliminary decisions, both recommended approvals and denials. The report also includes a breakdown of completions by type of case -- pre-reform, reform and *ABC*. Where the cases are delineated in two categories (pre-reform and reform), *ABC* cases may be included in both categories, depending on the date of filing the asylum application (pre or post January 4, 1995). *ABC* cases included in the reform category are not subject to the 180-day work authorization clock period.
- A third change occurred with the June 1997 data, which showed a vast increase in the number of cases administratively closed. The Asylum Program undertook a project to identify active cases from the pre-reform non-*ABC* backlog. Mailers were sent to 90,000 applicants in the backlog to determine their continued interest in pursuing their asylum requests. Applicants no longer interested in pursuing an asylum claim could request withdrawal of the application; cases without good addresses were administratively closed; and the remaining caseload will be scheduled for interview as slots become available. The process of closing inactive cases under this program continued through FY 1997.

Changes to Asylum Data in FY 1998:

- Effective January 28, the AOC suspended scheduling and processing of *ABC* cases. This action was implemented while the INS develops regulations and procedures for cancellation of removal processing for eligible beneficiaries under the Nicaraguan Adjustment and Central American Relief Act. This new process will be integrated into the affirmative asylum process so that the AOC will grant cancellation of removal to those eligible for the benefit and refer to an immigration judge applications for cancellation of removal that the AOC cannot grant.

- Increased receipts due to the one year filing deadline. Beginning the last week in March, and ending the last week in April, the Asylum Program experienced a marked increase in the number of new receipts. The Asylum Program received 5,000 more new receipts than the previous month during this timeframe. This surge was expected from asylum seekers who have been in the country for long periods of time filing prior to the implementation of the one-year filing deadline on April 1, a requirement of the 1996 Act. Asylum seekers must now apply for asylum within one year of entering the United States. The statute does provide for exceptions to this provision under extraordinary or changed circumstances.
- Beginning in March, the fingerprint process for asylum applicants was changed. Applicants no longer file fingerprints with their asylum applications. Applicants are scheduled for fingerprint appointments at an INS Application Support Center, as are applicants for all other benefits. As a result of this administrative change, there was a decline in final approvals while the new fingerprint process was fully implemented. By June, final approvals again reached completion on a large scale.
- Beginning in July, data on rejected applications are compiled in the workload and completions tables. These represent applications rejected under the one-year filing deadline, which became effective on April 16.

Changes to Asylum Data in FY 1999:

- Beginning March 1999, a new report was developed to track fingerprint responses of principal applicants and all dependents with recommended approvals. This report allows offices to process cases that are now cleared for a final grant of asylum. Due to this report, and the office's efforts to process these cases, the approval rate in March 1999, was significantly higher.

Changes to Asylum Data in FY 2000:

- On June 21, 1999, the INS began receiving a new benefit application, form I-881, Application for Suspension of Deportation or Special Rule Cancellation of Removal. Upon receipt of the new application, and completion of all identity and security checks by the FBI, applicants will be scheduled for NACARA interviews at asylum offices with jurisdiction. As of the end of April 2001, the INS had received 90,890 I-881 applications for suspension of deportation or special rule cancellation of removal. Interviews began in October 1999.
- Due to the high rate of asylum withdrawals by applicants granted NACARA benefits, the Asylum Program has experienced a corresponding increase in the rate of asylum cases that are Administratively Closed.
