For much of the past 30 years, global migration governance has focused on harmonization across borders. In recent years, however, that trend has reversed. Many countries are reasserting national control over migration policy, emphasizing sovereignty and security in response to geopolitical instability, demographic shifts, climate pressures, and changing labor markets. As a result, migration pathways are increasingly fragmented into nationally defined systems. This session examines the legal and policy drivers behind this shift and explores its implications for asylum systems, migrant rights, and international migration law.
