## FOD Leadership:

Headquarters Field Operations Directorate (HQ FOD) has completed the review of all pending asylee and refugee adjustment of status applications and is lifting this temporary pause, effective immediately. Later today, HQ FOD will provide field leadership with further guidance and instructions on the cases that can be processed without an interview using the Work Distribution System (WDS) and those that will require interviews prior to adjudication.

## **Background:**

On Mar. 21, 2025, HQ FOD placed a temporary pause on adjudicating Asylee and Refugee based Adjustment of Status applications pending the completion of additional screening and vetting to identify potential fraud, public safety, or national security concerns. This change was in alignment with Presidential Executive Order 14161, Protecting the United States from Foreign Terrorists and Other National Security and Public Safety Threats, and Executive Order 14157, Designating Cartels And Other Organizations As Foreign Terrorist Organizations And Specially Designated Global Terrorists.
