Update on Temporary Protected Status for Ukraine (Release: Sept. 03, 2026)

This guidance supplements the [SAVE Update on TPS for Ukraine](#) posted on Aug. 14, 2026.

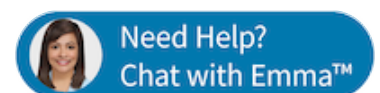
The Temporary Protected Status (TPS) designation of Ukraine and related benefits are set to terminate on Oct. 19, 2026. USCIS is sending notices to Ukraine TPS recipients who filed a Form I-765, Application for Employment Authorization, to obtain a Form I-766 Employment Authorization Document (EAD) under category A12 or C19 during one of the last re-registration periods for TPS for Ukraine, continue to be eligible for TPS, and who were issued an EAD with category codes A12 or C19 that expires before the end of the TPS designation period on Oct. 19, 2026. The notices state that their expired TPS-based EADs are extended until Oct. 19, 2026, the end of the Ukraine TPS designation.

SAVE will verify if an alien has received an approval for TPS that has not been withdrawn using information from any TPS-related document, such as a Form I-797, Approval Notice, or Form I-797C, Notice of Action or Notice of Continued Evidence of Work Authorization, and TPS beneficiaries will receive a SAVE response of:

- “Temporary Protected Status – Employment Authorized - Temp Emp Auth”; and
- The employment authorized through date will be the Employment Authorization Document (EAD) expiration date of “**Oct. 19, 2026**”

ALERT: The Temporary Protected Status (TPS) designation of Ukraine and related benefits are set to terminate on Oct. 19, 2026. USCIS is sending notices to Ukraine TPS recipients who filed a Form I-765, Application for Employment Authorization, to obtain a Form I-766 (EAD) under category A12 or C19 during one of the last re-registration periods for TPS for Ukraine, continue to be eligible for TPS, and who were issued an EAD with category codes A-12 or C-19 that expires before the end of the TPS designation period on Oct. 19, 2026. The notices state that their expired TPS-based EADs are extended until Oct. 19, 2026, the end of the Ukraine TPS designation. USCIS will send the notices by mail and electronically to those who have a myUSCIS account.

Completing Form I-9:

If your employee has a qualifying TPS-based EAD, they should receive a notice from USCIS informing them of this automatic extension of their EADs to Oct. 19, 2026. If so, they may choose to present the following combination of documents as proof of identity and continued employment authorization under List A, valid until Oct. 19, 2026:

- An EAD that has an expiration date of any date on or after April 20, 2026, and before Oct. 19, 2026; and
- The USCIS notice extending their EAD.

When completing the “Expiration Date (if any)” fields on Form I-9, input in Section 1 and Section 2 “**Oct. 19, 2026**” along with a note in the Additional Information box. Employers may download the Alert and TPS Ukraine Automatic Employment Authorization (EAD) Extension webpage and attach them to Form I-9, along with the USCIS notice. When completing a case in E-Verify, enter the expiration date of “**Oct. 19, 2026**,” from the Form I-9.
