Subject: E-Verify Records Disposal

Have you been using E-Verify more than 10 years? If yes, please download the new Historic Records Reports by March 31, 2017.

In April 2017, USCIS must dispose of transaction records that are over 10 years old. We have created a Historic Records Report that contains transaction records dated on or before Dec. 31, 2006. E-Verify employers may download these records from now through March 31, 2017.

E-Verify encourages you to record the E-Verify case verification number on the relating [Form I-9, Employment Eligibility Verification](#), and to retain the Historic Records Report with Form I-9.
