

Mission

SEVP collects, maintains, analyzes and provides information so only legitimate foreign students or exchange visitors can gain entry into the United States, while protecting the nation's security. The result is an easily accessible information system that provides timely information to Department of State, U.S. Customs and Border Protection, U.S. Citizenship and Immigration Services, and U.S. Immigration and Customs Enforcement, as well as a number of other federal law enforcement agencies who have a vested interest in F, M and J nonimmigrants.

This mission rests upon three pillars:

Protecting the Nation:

Our top priority is the safety of the United States and our citizens. We accomplish this by directly supporting ICE law enforcement activities and the work of numerous other agencies and task forces.

Public Diplomacy:



Schools

School Certification

The Student and Exchange Visitor Program's (SEVP) School Certification Unit certifies schools to accept F (academic) and M (vocational) students. By certifying only bona-fide institutions and enforcing strict compliance standards, SEVP protects not only the students, but also national security.

To file for SEVP certification, school officials must complete Form I-17, "Petition for Approval of School for Attendance by Nonimmigrant Student," and pay the application fee. After a school becomes SEVP-certified, designated school officials (DSOs) can issue Forms I-20, "Certificate of Eligibility for Nonimmigrant Student Status," to prospective F or M students after they have been accepted for a program of study.

DSOs are responsible for continuously updating the school's information to make sure that SEVP is provided with the most upto-date, accurate information.

Recertification

DSOs, acting on behalf of SEVP-certified institutions, must complete recertification every two years to confirm compliance with SEVP eligibility, record keeping, and recording requirements on F and/or M students at the following types of schools:

- Universities;
- Colleges;
- Seminaries:
- Conservatories;
- Academic high schools;
- Elementary schools;
- Language schools;
- Vocational schools;
- Flight schools; and
- Other post-secondary institutions.

DSOs will receive notification, via the Student and Exchange Visitor Information System (SEVIS), when they are within the 180 days of the school's certification expiration date (CED). The principal DSO will be responsible for submitting a complete recertification petition package

prior to the CED. SEVP's website (www.ice.gov/sevis) has detailed information on the recertification process. Failure to file for recertification will result in the automatic withdrawal of SEVP certification.

SEVIS

SEVIS is the Web-based system that the Department of Homeland Security (DHS) uses to maintain information on the following:

- SEVP-certified schools;
- Department of State-designated exchange visitor program sponsors;
- F, M and J nonimmigrants.

Resources

SEVP Response Center

Compliance

SEVP Analysis and Operations Center Established in 2011, the SEVP Analysis and Operations Center (SAOC) provides all SEVP stakeholders with a single interface for high-quality, timely analytical products, school compliance and student issue services. Specifically, the SAOC focuses on the types of efforts that:

- Pertain to school compliance, student status issues and support, incident response and emergency operations;
- Support SEVP analytical and data requirements; and
- Involve studies and analyses that inform policy, identify operational efficiencies, and determine systematic vulnerabilities and their mitigation.

Policy

SEVP Policy develops and updates the federal regulations that govern F and M students and that relate to school certification. The primary regulations are 8 CFR 214.2(f) and (m) as well as 8 CFR 214.3 and 8 CFR 214.4. SEVP Policy also writes interpretive documents and policy guidance to help stakeholders better understand and apply the regulations. SEVP's Policy Team works on regulations and guidance that support both the DHS mission and the effective use of SEVIS.
