SUBJECT: Organizations Ineligible for Approval of Immigrant and Nonimmigrant Petitions Under Section 212(n)(2)(C)(ii) of the Act.

The U.S. Department of Labor has informed the Bureau of Citizenship and Immigration Services that pursuant to 20 CFR §655.855(d), they have found the organizations named below to have violated the Immigration and Nationality Act (Act). Pursuant to section 212(n)(2)(C)(ii) of the Act, immigrant and nonimmigrant petitions shall not be approved with respect to the named employer(s) for the period indicated below. For the period indicated, a petition may not be approved where the listed organization is the petitioner or employer. This ban does not affect petitions that were previously approved.

The table below summarizes all organizations currently subject to this ban, and the period for which the ban is in place with respect to that organization. There are thirteen organizations listed in this update of the table.
